He is co-editor of the "Journal of European Consumer and Market Law" and of "The Italian Law Journal". He is Member of the Academia Europaea. His research deals with Law of Obligations and Contracts, with focus on digital economy and sustainability.

Laurynas Didžiulis is a docent at Vilnius University teaching civil law of property and contracts. From 2014 he holds a PhD in private enforcement of EU financial regulation and was recognized as an exceptional junior scholar in 2016. He is an author of several books and articles on various issues of Lithuanian civil law. He is an advocate of civil law and a recommended arbitrator at Vilnius Court of Commercial Arbitration. Hans Christoph Grigoleit received his legal education at the Universities of Tübingen and Munich (1984-1989). He then achieved an LL.M. from the University of Miami (1990), obtained his doctorate in 1996 and his habilitation in 2003 at the University of Munich. In his PhD-thesis he dealt with "Pre-Contractual Information Liability" (1996) while his habilitation study concerned "Shareholder Liability" (2003). After his first teaching position as a professor at the University of Regensburg (2003-2009), he returned to the University of Munich in 2009, where he has since been holding a Chair for Private Law, Commercial Law, Corporate Law and Theory of Private Law.

Geraint Howells is Executive Dean for Business, Public Policy and Law at the University of Galway. Previously he was Professor of Commercial Law at Manchester University, where he remains a visiting professor. He has been Dean of Law at the City University of Hong Kong and Head of the Law Schools in Manchester and Lancaster. Reiner Schulze is Professor of German and European civil law and Director of the Centre of European Private Law at the University of Münster (Germany). His main research interests are in the field of European trade and consumer protection law; the law of obligations (in particular contract law and tort law) and international contract law; and history of European Community law. He is a founding member of the European Law Institute; a honorary member of the Spanish "Real Academia de Jurisprudencia y Legislación"; a member of the Italian "Accademia Nazionale dei Lincei"; and of the Academia Europaea.

Karin Sein is a Professor of Civil Law and the Deputy Head of the Institute of Private Law in the Faculty of Law of the University of Tartu, Estonia. Her main research interests cover domestic and European contract law, consumer law, private international law and digital law. During 2018-2021, she was the PI of a scientific project funded by the Estonian Research Council concentrating on consumer contract law in the Digital Single Market. She has provided expertise for the Estonian Ministry of Justice on implementing European consumer protection directives into Estonian law. During the Estonian EU Presidency in 2017, she was acting as a Chair for the Council Working Group on Contract Law.

Rita Simon, LL.M., is a senior researcher at the Institute of State and Law, and has focused on consumer protection and sustainable consumption from a comparative perspective since 2017. She studied law at ELTE in Budapest and holds a LL.M. degree (2001) and a Ph.D. in European Competition Law from the University of Cologne (2005). She worked for various German institutions, such as the Centre for European Integration Studies in Bonn and the Eastern Law Institute at the University of Cologne and served as an associate in the Bureau for Civil Law Codification at the Hungarian Ministry of Justice. Fidelma White is a Senior Lecturer at the School of Law, University College Cork, Ireland, where she teaches and researches on consumer and commercial law.
