Contributors

JOHN BOSSY was born in London in 1933, and is a graduate and Ph.D. of Cambridge. From 1966 to 1978 he taught at Queen's University, Belfast, and is now Professor of History at York. His work has been in the history of English Catholicism, on which he published *The English Catholic Community*, 1570–1850 in 1976; and on the social history of western Christianity both before and after the Reformation.

JAMES CASEY is the author of *The Kingdom of Valencia in the* Seventeenth Century (1979). He teaches European history at the University of East Anglia. His current research is on family structure and social networks in Andalusia in the early modern period. He was born in Belfast in 1944, and is married with two children.

NICOLE CASTAN, whose background is in law and history, is a Professor at the University of Toulouse II. Her work has been concerned with the analysis of social regulation and judicial practice in Languedoc during the later eighteenth century: a watershed in the history both of crime and of its resolution, which was then still to a considerable extent achieved by mediation.

MICHAEL CLANCHY is Reader in Medieval History at the University of Glasgow. He has edited legal texts for the Selden Society and the Wiltshire Record Society and is the author of *From Memory to Written Record: England 1066–1307* (1979), which relates legal records to the growth of literacy. His most recent book is *England and its Rulers 1066–1272* (1983).

JOHN GILLIS holds degrees from Amherst College and Stanford University. He is the author of Youth and History (1974) and The Development of European Society, 1770–1870 (1977). His most recent research on the history of working class marriage in England and Wales, 1600 to the present, will be published in 1985. He has

taught at Stanford and Princeton, and is now Professor at Rutgers University.

DIANE OWEN HUGHES received her Ph.D. at Yale, has taught at Toronto and is at present at Amherst College. Her work has been on medieval urban and family history, and she is engaged on a comparative study of the cities of Genoa, Marseilles and Barcelona.

EDWARD JAMES is a member of the Department of History at the University of York. He has published a number of studies of Frankish history and archaeology, including *The Merovingian Archaeology of South-West Gaul* (1977) and *The Origins of France* (1982). Among other works in progress is a translation of some of the hagiographical works of Gregory of Tours.

RICHARD L. KAGAN received his Ph.D. at Cambridge in 1968. He has taught at Indiana University and the Johns Hopkins University, where he has been a Professor of History since 1979. His publications include *Students and Society in Early Modern Spain* (1974) and *Lawsuits and Litigants in Castile*, 1500–1700 (1981). He is writing a book on *The Toledo of El Greco*.

SIMON ROBERTS was born at Micheldever, Hampshire in 1941. He read law at the London School of Economics, then taught at the School of Law in Malawi, where he became interested in legal anthropology; he later did two years' field research in Botswana. His publications include *Law and the Family in Africa* (ed., 1977), *Order and Dispute* (1979) and (with John L. Comaroff) *Rules and Processes* (1981). He is at present Reader in Law at L.S.E.

J. A. SHARPE is a B.A. and D.Phil. of Oxford and, after holding temporary posts at Durham and Exeter, has lectured in history at the University of York since 1973. He is the author of several articles on crime in early modern England, and of *Crime in Seventeenth-Century England: a County Study* (1983).

JENNY WORMALD is a graduate of Glasgow, a Lecturer in Scottish History there, and at present British Academy Reader in the Humanities. As Jennifer M. Brown she edited and contributed to Scottish Society in the Fifteenth Century (1977); she is general editor of the New History of Scotland (Arnold), and author of volume 4, Court, Kirk and Community: Scotland, 1470–1625 (1981). She is writing a book on James VI and I.

Editor's Note

Six of the chapters in this volume (1, 3, 4, 6, 7 and 10) were, in their original form, contributions to the Past and Present Conference on Law and Human Relations, held in July 1980. All of them are here published for the first time, with the following three exceptions: chapter 5, by Jenny Wormald, appeared in *Past and Present*, no. 87 (May 1980); parts of chapter 6, by Richard Kagan, appeared in his *Lawsuits and Litigants in Castile, 1500–1700*, published by the University of North Carolina Press, Chapel Hill, 1981; chapter 9, by Nicole Castan, is a translated version of chapter 1 of her *Justice et répression en Languedoc à l'époque des Lumières*, published by Flammarion in their Collection 'Science', Paris, 1980. The editor and the Past and Present Society are extremely grateful to the authors of all three, and to the publishers of the last two, for allowing their contributions to appear in this volume.
